Your personal data are collected and processed for the purposes set out below together with the legal basis of reference:

The processing of your data is based on legitimate interests of the data controller recognized by the law, in particular:

Purpose	Legitimate Interest of the Owner
Monitoring of contractual obligations	Monitoring of the obligations related to sales contracts with customers. It Includes all operations aimed at concluding the sale.

Your data may be sent to the recipients or categories of recipients listed below:

Target categories:

- Consultants and freelancers in single or associated form (Professional Studies)
- Non-economic public bodies (Revenue Agency)
- Banks and credit institutions (Banks)
- Judicial Offices (Police Headquarters)
- Employers (Owner)

In addition to this information, to ensure the correct and transparent processing of your data, you must be aware of the fact that:

- The duration of the treatment is determined as follows: 5 years from the date of termination of the contract (Article 2948 of the Civil Code which provides for the 5-year prescription)
- You have the right to ask the data controller to access your personal data and correct or cancel them or limit their process or oppose their treatment
- If you have given consent to one or more specific purposes, you have the right to revoke this consent at any time
- You have the right to complain through the following Supervisory Authority: Guarantor for the protection of personal data



Moreover,

- You have the legal obligation to provide your data otherwise you will be subject to penalties as required by law
- You have the contractual obligation to provide your data, the absence of which is considered a violation of the clauses contained therein, as the knowledge of your personal data is a necessary requirement for the conclusion of the contract and it will not be possible to proceed with its stipulation in the absence of them

The involved party has the right to the portability of his / her personal data.

The processing takes place through automated processes which do not determine the profiling of the involved parties.
